- 2) As per the sampling and container stuffing procedure followed by the Board, it is **mandatory** on your part to get the following export consignments are sampled and tested for;
 - a) Chilli/chilly powder and products containing chilly for Aflatoxin and Sudan (unauthorized colourant)-I, II, III & IV as the case may be.
 - b) Turmeric Powder, for Sudan-I, II, III & IV colourant,
 - c) Sugar coated Fennel Seed for presence of Sunset Yellow
 - d) Nutmeg and Mace, Turmeric, Ginger to EU countries for Aflatoxin
